

iLEAD Schools - Content Release Form

This release concerns all media content (photographs, videos, sound recordings, websites, online content, testimonials and other documents) taken of or created by me and/or my minor or dependent child and related to any and all iLEAD Schools entities in the course of regular school activities. I hereby grant the iLEAD Schools permission to take my and/or my minor child's photograph, record my voice, shoot film/video footage of me and/or my minor child, and document my and/or my minor child's testimonial as it related to the mission of the iLEAD Schools (hereinafter referred to in this document as the "Works.")

I understand that the "Works" will be used by the iLEAD Schools, and may contain personal information that is protected by law from disclosure (California Civil Code Section 1798.24). Therefore, by signing this release, I give my permission to the iLEAD Schools to use the Works for any purpose identified herein or related to or in furtherance of the same. These purposes may include any or all of the following:

- <u>Training.</u> The iLEAD Schools may use the Works in training manuals, Power Point

I agree that the Works may be used and disclosed by the iLEAD Schools as described in this form as long as the iLEAD Schools uses the Works in the manner described.

I hereby grant to the iLEAD Schools, the absolute and irrevocable right and permission to use the Works for educational, informational and promotional efforts, and in particular in the manner described in this form. I understand that my signature on this form signifies my consent to grant the following rights in the Works to the iLEAD Schools:
